Whereas Ardersier Port Limited⁽¹⁾ is a harbour authority within the meaning of the Pilotage Act 1987⁽²⁾ (“the 1987 Act”) for the harbour of Ardersier but is not a competent harbour authority within the meaning of the 1987 Act;

And whereas Ardersier Port Limited wishes to be treated as a competent harbour authority for the purposes of the 1987 Act;

And whereas the Scottish Ministers have informed the persons they consider might be affected by this Order, in accordance with section 1A(2)(b) of the 1987 Act, and the making of the Order is not opposed; Now therefore the Scottish Ministers, on the application of Ardersier Port Limited, in exercise of the powers conferred by section 1(4) of the 1987 Act⁽³⁾ and of all other powers enabling them in that behalf, hereby make the following Order:

- (1) A company incorporated under the Companies Acts (company number 03700403) and having their registered office at Level 4, Dashwood House, 69 Old Broad Street, London EC2M 1QS and which became the harbour authority for the harbour of Ardersier by virtue of Article 4 of the 2017 Order
- (2) [1987 c. 21](#).
- (3) The functions conferred on the Secretary of State were transferred to the Scottish Ministers by virtue of section 53 of the Scotland Act [1998 \(c. 46\)](#).

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Ardersier (Pilotage Powers) Order 2024 and shall come into force on [] 2024.

(2) In this Order—

“2014 Order” means the Port of Ardersier Harbour Revision Order 2014 (1)

“2017 Order” means The Port of Ardersier Harbour Revision (Transfer) Order 2017 (2)

and

“the harbour of Ardersier” means the area described in Article 17 of the 2014 Order.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order provides that Ardersier Port Limited shall be a competent harbour authority for the purposes of the Pilotage Act 1987 in respect of the harbour of Ardersier.

The applicant for the Order is Ardersier Port Limited having their registered office at Level 4, Dashwood House, 69 Old Broad Street, London EC2M 1QS
